

PISTOL PERMIT APPLICATION, THE STATE OF ALABAMA, RUSSELL COUNTY

Permit not transferable to another person. If a pistol is necessary in your work, you must obtain a letter of request from your employer. If you have been convicted of a crime of violence **IT IS UNLAWFUL FOR YOU TO POSSESS A PISTOL**. If you are not a full time resident of Russell County, **YOU CAN NOT APPLY**. The law prohibits the Sheriff of one county issuing a permit to a resident of another. **(FALSE INFORMATION WILL SUBJECT PERMIT TO REVOCATION AND/OR PROSECUTION.)** **WARNING:** Federal laws regulate possession of firearms in certain areas of air terminals.
